18th Annual Report of the Trustees for the year ending October 31st 2024

It is a delight to report that our battle re-enactments, coinciding this year with the original dates of September 21st and 22nd, were deemed "the best ever" by one and all since we launched in 2006. But why? The re-enactments, exhibitions and the myriad activities hubbed year round from Prestonpans Town Hall deliberately maximise engagement with visitors from far and wide and of all ages. Put simply however, this year we comprehensively broke through the Fourth Wall. All day long visitors were invited to meet and talk with each and every re-enactor group. We began with a roll call of the Regiments and Clans present at the battle and Gaelic song. Redcoat soldiers and Highlanders openly shared their personal encampments, Sir John Cope and Prince Charles invited visitors to listen in on their briefings, the 1722 coal waggon rolled by, the naval cannoniers from HMS Fox shared their mighty weaponry, redcoat dragoons demonstrated their skills and youngsters took up arms for The Prince. This comprehensive opportunity to meet, talk and see, carried visitors from museum artefacts, books and battlefield walks to the actual moments of battle brilliantly and accurately narrated – the cannons fired just the once, the sailors fleeing as the Highlanders charged and the dragoons fell into confusion. Redcoat infantry stood its ground but to no avail.

This spectacular re-enactment, presented every three years in partnership with the Scottish Battlefields Trust, was the year's finale. But much else has gone along, not least the rotating exhibition of the Battle of Prestonpans Tapestry in Prestonpans Town Hall and the sequence of secondary exhibitions in the Jubilee Room. And the popularity of educational school visits has not waned, frequently linked to battlefield walks.

Of particular significance was the launch of the nationwide Jacobite Festival, pioneered by the late Sir Herbert Coutts and Dr Mike Taylor. The Jacobite Trail website from which it has been built since 2019 now includes over 80 locations and for the inaugural National Festival in August 2024 offered special events.

Just as remarkable was the success of the 10th Anniversary celebration exhibitions of the Scottish Diaspora Tapestry. Opening with Scottish 'Connections' Government support in March at Dalkeith Palace, the panels were presented for the first time by occupations rather than countries. It was followed by two months at Veere in the Netherlands, two months on a unique safari across East Lothian in 11 museums and centres, and finally at Helmsdale where The Emigrants statue stands.

Campaigning for a decade now at Blindwells to ensure 'thoroughgoing mitigation and enhancement of interpretation and understanding of the battle' has begun to show fruit. The delineation of the Riggonhead Defile and a comprehensive display of the Battle Tapestry along the planned High Street both seem likely outcomes alongside existing plans for The Prince's Loch. An Exclusivity Agreement has been proffered by developers Hargreaves for the possibility that the Trust's eventual permanent home *might* be established on the new build High Street — which is being proactively explored against the background of the present county and national economic climates which will make timeous progress truly challenging.

Beyond the Battle ...

There's been no pause in our commitment to creative research programming. With Historic Environment Scotland's support an 18 month analysis of the evolution of the 1745 Prestonpans community and landscape to the present day is under way. Agriculture, crafts and trades often gave way to coalfields, marshlands have been drained, schooling and new housing introduced; but many built structures such as Preston Tower, Prestongrange Church, Bankton and Cockenzie Houses remain and some families continue to live here. Our

county museum carries many artefacts from the intervening years including Fowler's Brewery, myriad potteries and glass making, brickmaking and salt panning. The 280th Anniversary of the battle in 2025 will celebrate the results of this unique research programme. And it is paralleled by Mark 2 of the Trust's *Whatlf*? strategic evaluation of the Prince's campaign and Sir John Cope's response. Mark 1 *What If*? began with The Prince's departure from Edinburgh into England ending in final defeat at Blair Atholl despite support from the French materialising in the south and their unexpected impact including their destruction of Chatham Docks to inconvenience the Royal Navy. Its sequence captured the interest and support of hundreds on Facebook and, building from that interest, Mark 2 has taken an earlier starting moment to begin a fresh strategic re-evaluation – the Raising of the Standard at Glenfinnan.

Financial management and risk analysis

The Trust's activities since taking on the lease at the Town Hall in 2021 have involved fixed overheads expenditure and consultant curator and contractor fees. These have been successfully funded by personal donations received, grant aid by East Lothian Council, most welcome HMRC 'Exhibition Tax Credits', the sale of books and merchandise, school and tour group visitor fees and any hypothecated share of research programme budgets. And long may that continue. But none of these funding streams are guaranteed and success in gaining such support relies on imaginative and focussed activities, including at home and touring exhibitions. The risk is permanently with us that we shall not always be able to create and/or gain support for such initiatives and maximise our schools programmes and exhibition activities attracting donations and tax credits. We might even need to consider making entry charges to the Museum. But we have the support of an ever-growing body of knowledgeable volunteers who enable so much to be delivered – some stitchers, some historians, all are offered opportunities to develop their skills and to share their understanding of the Trust's work with visitors. This was nowhere more apparent than at the Dalkeith Palace Exhibition and throughout the Re-enactments and Living History Exhibition in which latter event the Alan Breck Regiment of Prestonpans Volunteers, as ever, took pole position with great dignity.

And talking of our volunteers it has been gratifying during the year to have been successful in gaining Levelling Up/ UK Regeneration and FCC Recycling funding for the refurbishment of their Green Room and Kitchenette and for our Public Toilet Facilities. We've also been able to restore the Victorian Lantern on the steps of the Town Hall and to create a commemorative Honours Board for Provosts of the Burgh of Prestonpans.

2023/ 2024 has been a spectacular year for the Trust reaching out to thousands with the Diaspora Tapestry's 10th Anniversary programme, addressing the continuing stream of school groups, greeting visitors every weekend at the Museum to see our permanent and rotating displays and focussed exhibitions, and hosting thousands at the September exhibition and re-enactments.

When we took the peppercorn lease in 2021 to restore Prestonpans Town Hall and to institutionalise our campaign from there we did so with generous support of VisitScotland and Covid Recovery funding known as *Adapt & Thrive*. It's not always been a straightforward progress but regularly enjoyable; we have been adapting apace and remain determined to thrive – howsoever.
